POLICIES & GUIDELINES

Eligibility

Puyallup tribal members with a permanent enrollment number assigned by September 28, 2021, pursuant to current tribal enrollment and service eligibility policies.

Students in Kindergarten through grade 12 who are under the age of 19.

Students enrolled in a certified Elementary, Middle or High School. Homeschooling is acceptable for grades K-12 with proper documentation.

Requirements**

Parent/Guardian must submit a completed application to the Educational Incentives Program.
(Some supporting documentation may be needed)

Students in Kindergarten 2021-22 will need verification of enrollment on school letterhead from the school they will be attending or an official class schedule.

Students ages 16-18 will need verification of enrollment on school letterhead from the school they will be attending or an official 2021-22 class schedule.

For custody disputes and court orders, please submit supporting court documentation.

Application should be submitted to the Education Incentives Program by August 3, 2021. Late applications and supporting documentation will not be accepted after September 29, 2021.

Check Disbursement

Checks may be delayed if your address is not up to date. Address updates should be done in accounting, enrollment and per capita.

In cases of custody or other disputes, decisions will be made based on the information submitted and available at the time of check disbursement. All decisions are final.

Checks will be disbursed to the permanent custodial parent. Checks will not be given to parents with vacation or summer custody.

**** Applications that are incomplete, illegible, late or not meeting the guidelines will be delayed or denied.**
